Below you will see an outline to assist in obtaining a needed appointment for Newborns of a COVID -19 positive parents.

- 1. Refer to attached form for instruction to give to patient prior to discharge
 - a. Complete patient name and appointment date and time prior to giving to patient. Providers should be aware that the appointments will only be made on Tuesday and Fridays at 2pm and 3pm on these days each week.
- 3. Call the CNE access center at 736-1988, or ext. 31988
 - a. Advise the access center that you have a Fast Track Baby for direct scheduling with Dr. Lukankina
 - b. Obtain date and time from scheduler and provide needed patient information
- 4. Post discharge summary, and any pertinent medical information should be faxed to the office of

Dr. Lukankina at: 729-6203(fax)

5. Should you have any questions for the office, please call them at: 729-2582

To help you to understand the process, the patients should be informed of the following:

- Patient will park in designated parking spot as assigned by the security booth
- Patient will present at the door where they will be greeted by staff in full PPE
- Patient and family will be led directly to a patient room where they will be
 - Checked in
 - Appointment completed
 - o Follow up apt made
 - Checked out
- Patient will be escorted to exit by staff

- Registration will take place in the exam room, and there will be no need to wait in a waiting room or be concerned that your newborn will come in contact with others during this time.
